2. Scholarship to the needy students has been at the hearts of the Pudu Rotarians since the year 1971.
3. In Rotary Year 2009/ 2010, under the leadership of PP Robin Tay, I set up a committee to co-author the book *"A Footprint of a Judge's Journey through Mother Earth"* a collection of judgments of the late Dato Vincent Ng, a Judge of the Court of Appeal.
4. We invited the then Chief Judge of Malaya, now the Chief Justice Tun Arifin Zakaria to launch the book and raised a sum of RM120,000 in cash and RM20,000 in kind, to set up the "Dato Vincent Ng Scholarship Fund" within the framework of our Pudu Rotary Club Charity Foundation (PRCCF).
5. We would like to acknowledge the fact that the interest earned from the Mr Justice Dato Vincent Ng Scholarship Fund together all the other funds listed in this booklet is the main source of the funds to be disbursed today.
6. When I was granted an opportunity to lead the club in the Rotary Year 2013/ 14, by God's grace, the economy of Asia and particularly Malaysia was in a

pink of health. During the better days, in terms of economy, we were very lucky to close Rotary Year 2013/ 14 with one last fund raiser on June 28, 2014 which raised about RM240,000 for the poor and hungry, in total, Rotary Year 2014/ 15 raised over RM360,000 vide various projects.

7. Every year, the amount of funds to be disbursed the students is determined by the President and his/ her board of directors from the amount of funds available for any particular Rotary Year. Due to the economic situation, this year we will be giving out about RM29,000 principally from the interest accrued from the various funds in the PRCCF and a kind donor ELITE FORTE CONSTRUCTION SDN BHD.
  
8. It is my sincere hope that in the economy in the coming years will be much better and we will be able to make more funds available to more needy students.
  
9. Finally, the Rotary Club of Pudu wishes all the scholarships and grants recipients a successful academic year in 2015.

SOME ROTARY INFORMATION FOR NON ROTARIANS

Rotary was started by a young Chicago lawyer named Paul Percy Harris on the 23rd February 1905. Paul Harris had the simple idea that men in business should be personal friends rather than acquaintances. He gathered three friends to share his idea, namely, Silvester Schiele – a coal dealer, Gustavus E. Loehr – a mining engineer and Hiram Shorey – a merchant tailor.

These early “Rotarians” decided that membership to the club should not come from a single profession or business sector but should be limited to one representative from each business or profession and this is how today the membership of Rotary is restricted by the “classification” system.

The meeting place was to be at each member’s place of business in turn so that every member can have a better understanding of his fellow member’s job or business. Since the meeting place was to be in rotation, Paul Harris suggested that the name of the club should be “Rotary”. This was readily agreed upon and out of a simple idea the first club of business and professional men united in the ideal of fellowship was constituted.

This simple idea grew to become the greatest service organization the world has ever known. Membership increased and it spread rapidly across the Atlantic in 1911 where clubs were formed in England, Scotland and Ireland. In 1922 its name was eventually changed to Rotary International.

Rotary's ideal spread to many countries including Cuba and the Far East – e.g. Philippines, China and India. It has become a worldwide movement for service that has transcended national boundaries, language limitations and barriers of race, colour and creed.

It is an organization well known for its diverse humanitarian efforts e.g. its relentless efforts to rid Polio from the surface of the earth under its PolioPlus programme. It is truly an organization which renders “Service Above Self”.

The Rotary movement has since grown to over 1.2 million members in more than 34,000 Rotary Clubs in more than 200 countries in the world. It is a movement that has advanced international understanding, goodwill and peace throughout the world.

## THE PUDU CLUB CHARITY FOUNDATION SCHOLARSHIP

### 1. THE SCHOLARSHIP SCHEME

In 1971, Charter President of Rotary Club of Pudu, the late Past President Douglas Fraser, went specifically to Australia to seek participation and support from friends and Rotarians in Australia in a unique project to promote better world understanding between Australia and Malaysia.

The project was very simple. Each Australian donor was invited to contribute A\$50 which at then was about RM125.00 in the form of educational support to a deserving Malaysia student to be selected by the Rotary Club of Pudu. The educational support was to be used for the purchase of school uniforms, books, the payment of examination fees or other related educational expenses. Recipients were by rule requested to correspond with their donor.

### 2. BENEFITS

The students receiving the scholarships had to communicate via letters and reports with their donors. That communication created better international understanding of the way of life and cultures of Australia and Malaysia between the donors and recipients.

Apart from learning about the culture, the awardees also benefitted from the information, guidance and advice of their donors. The correspondence also helped to improve their command of the English Language, an international language of great importance. The Malaysian schools had at then started Bahasa Malaysia (Malay) as the medium of instruction in schools.

To the donors, more than having a better understanding of Malaysia was knowing that their small contribution had helped a poor student to meet at least part of his or her educational expenses.

Many strong, close and lasting relationships developed from the correspondence between the Australian donors and Malaysian recipients. There were even cases of

donors providing totally paid holidays to Australia for their awardees. Many Australian donors also asked for meetings be arranged with their awardees when they visited Malaysia.

### 3. DONORS

The initial funding for the above project came mainly from Australia. Donation from the Australia Rotary Clubs was through World Community Service. This however had been substantially reduced in the mid-eighties when the Australian Rotary Clubs initiated a programme to centralize all such donation leaving Australian Rotary Clubs from one source.

The project has been very successful. From the date of inception to-date, slightly more than a million Malaysian Ringgit have been received from Rotary Clubs, Rotarians, friends in Australia as well as Pudu Rotarians and other Malaysians. Several thousand students have benefited from the scheme and surely the cause of International Understanding had been advanced through this simple project.

Since 1987/88, Pudu Rotary Club initiated fund raising events to support this Scholarship Programme. The funds raised were capitalized and only the interest earned was used for the scholarships and educational grants to deserving students. To-date, the club has capitalize more than half a million ringgit for this secondary scholarship (apart from the funds for University Grants).

### 4. HISTORY

Over the years since its inception in 1971, more than RM 1 million has been disbursed to deserving secondary school students and undergraduates. Each year, the scholarship disbursements were partly funded from annual interests earned from the capitalized sum, as well as additional cash donations from generous donors and funds raised from our annual fund raising activities.

The recipients of the scholarships and educational grants are mainly poor and deserving students in secondary schools and local institutions of higher learning within the territorial limits of Rotary Club of Pudu. The deserving recipients are mostly selected through the recommendation of the Principal of the recipients' respective school.

Records of the recent 28 years:-

- In RY 1984-85, 46 clubs and individuals donated a total of RM 15,890.98 for the project benefiting 133 students from 9 schools within the territorial limits of Pudu Rotary Club. Mr. Robert Bowker, Australia's Deputy High Commission was present at the presentation ceremony.
- In RY 1985-86, 27 clubs and 17 individuals donated a total of RM 11,743.93 benefiting 133 students from 10 schools. On 23rd September 1985, the then Minister of Welfare Services Dato' Abu Hassan officiated the Scholarship Presentation. His Excellency, Mr. R.M. Peek, the Deputy Australian High Commissioner also graced the occasion.
- In RY 1986-87, 28 Rotary Clubs from Australia, 29 Pudu Rotarians, one (1) well wisher and the Pudu Rotary Club Charity Foundation donated a total of RM 18,480.00 to 154 students from 12 schools.
- In RY 1987-88, 14 Rotary Clubs from Australia, the Australian High Commission and the Pudu Rotary Club Charity Foundation donated a total of RM 18,000 to 150 students from 12 schools.
- In RY 1988-89, 10 Rotary Clubs from Australia, the Australian High Commission, PLUS (a subsidiary company of United Engineering Bhd) and the Pudu Rotary Club Charity Foundation including a number of Pudu Rotarians raised a total of 11,681.30 benefiting 100 students from 10 schools.
- In RY 1989-90, 9 Rotary Clubs from Australia, Pudu Rotarians and the Rotary Club Charity Foundation donated a total of RM 18,120.00 to 139 students from 8 schools
- In RY 1990-91, donations totaling RM 15,000.00 were received and 132 scholarships of RM 130.00 each were given out.
- In RY 1991-92, 159 students received scholarship worth RM 17,500.00 of which a sum of RM 4,200.00 was donated by 10 Rotary Clubs from Australia.
- In RY 1992-93 under the dynamic leadership of President Choo Jee Sam set many firsts and records. A record number of 242 students from 7 schools received the grants amounting to RM 31,290.00.

For the first time, 2 undergraduate scholarships each worth RM 3,000.00 were awarded. We also awarded for the time the Pudu Rotary Club Charity Foundation Undergraduate Grant of RM 1,000.00 each for 5 students. Another first was the donations from individual well-wishers for RM 1,500.00 to RM 1,800.00 each with

the scholarship named after the donor. The money was capitalized and the interest drawn annually used to award to student. The donors in 1992-93 were:-

- In RY 1993-94, dynamic President Chow Tain raised approximately RM 200,000.00 from the Skeeter Davis Charity Dinner Concert to initiate the Vocational Scholarship Scheme. This scheme was to encourage and promote vocational education and training to enhance employment opportunities in line with the industrialization of our country and our goal to achieve Vision 2020. During RY 1993-1994, the following were implemented:-  
  
Another new aspect of scholarship during President Chow Tain's year was the emphasis of hope to the handicapped. Towards this, an undergraduate Scholarship worth RM 2,500.00 per year for 4 years was awarded to a worthy blind students, Ms. Chong Soo Lee, a first year student from the University Malaya.  
  
The Pudu Rotary Club also for the first time awarded the Audrey Siew Memorial Secondary School Scholarship for the handicapped. Five students from the School of the Blind and the School for the Deaf received RM 1,300.00 each. A total of RM 27,200.00 was awarded to 205 secondary students from 7 schools.
- In RY 1994-95, under the leadership of President Richard Liew, we awarded RM 24,000.00 worth of scholarships to 181 secondary school students. There were also two undergraduates, namely Ms. Kannamah a/p Mothan and Ms. Joyce Cheah Pik Yuen both from the UKM Bangi who received the Undergraduate Scholarship.
  - In RY 1995-96, under the leadership of President N.K. Jasani, a total of 165 students from 7 secondary schools received scholarships worth RM 25,940.00.

During this Rotary Year, the value of the educational support grant was upgraded from RM 150.00 to RM 180.00 for Form 4 to Lower 6 students while the Form 1 to 3

grants were upgraded from RM 120.00 to RM 140.00. The Club for the year also appreciated the contribution of then President N.K. Jasani who gave RM 1,500.00 in the name of his mother, Mrs. S. Jasani, and also Rtn. Bob Barth who motivated American International Assurance Company to donate RM 10,000.00 to our Pudu Rotary Club Charity Foundation's Scholarship Fund. During the year, the Rotary Club of Adelaide and Rotary Club of Cameroon both from Australia also contributed. Three University Grants were given instead and they were given to 2nd year students Ms. Kannamah a/p Mothan and Ms. Joyce Cheah Pik Yuen. There was a new recipient in Ms. Ranuka Devi, a first year electrical engineering undergraduate from the University of Malaya.

- In RY 1996-97, under President Pang Poke Shum, we were able to increase the total amount given in a year to RM 34,320.00 as secondary school scholarships. This was given to 222 deserving secondary students. In addition, 2 Undergraduate Scholarships worth RM 3,000.00 each were given to Ms. Chong Soo Lee and En. Fadhil bin Abdul Rahman, and 4 Undergraduate Grants worth RM1,500.00 each were also given. In total, an amount of RM 46,320.00 was given out.
- In RY 1997-98, under President Gary Lim, an even larger amount was disbursed out. In total 266 secondary students received the secondary scholarships worth of RM 41,000.00, while 2 Undergraduate Scholarships worth RM 3,000.00 each were given to Mr. Federick Ho Wing Keong and Mr. Joseph Raj and 4 Undergraduate Grants worth RM 1,000.00 each were awarded. YB Dato Khalid Yunus, the Deputy Minister of Education officiated the Scholarship Presentation.
- In RY 1998-99, under the leadership of President Dato' Muslim Ayob, total of RM 60,000.00 was awarded to 200 secondary students and 5 Undergraduate Grants. District Governor of District 3300, Dr. Paul K.C. Lee officiated the presentation. This was the biggest sum of scholarship ever given out by Pudu Rotary Club.

- In RY 1999-2000, under the able leadership of President Rosemarie Wee, a total amount of RM 49,360.00 was awarded to 290 secondary students with one undergraduate scholarship of RM 3,000.00 to Kalaiyarasi d/o Muniandy and 7 Undergraduate Grants of RM 1,000.00 each accorded to deserving students. Datin Seri Endon, the wife of the Deputy Prime Minister officiated the Scholarship Presentation.
- In RY 2000-2001, under the able leadership of President Y.K. Chew, a total amount of RM 48,500.00 was awarded to 250 secondary students, one undergraduate scholarship of RM 1,500.00, five undergraduate grants of RM 1,000.00 each and one undergraduate scholarship of RM 3,000.00. The generous donors who have donated the following amount to the Scholarship Fund were:-

▪ PP Shirley Thum	RM 3,000.00
▪ Mr. Liew Chon Lai	RM 5,000.00

Donation made by Mr. Robert Barth and PP Shirley Thum were capitalized and only interest drawn annually would be awarded to students.

- In RY 2001-2002, under the leadership of President Albert Lim, a total amount of RM 49,300.00 were awarded to 155 secondary students in a form of grant of RM 200.00 and RM 250.00 each, three undergraduate scholarships of RM 3,000.00 each and three undergraduate grants of RM 1,000.00 each. Y.B Dr. Tan Kee Kwong, the Deputy Minister of Land and Co-operative Development officiated the Presentation. The generous donors who have donated the following amount to the Scholarship Fund were:-

▪ Mr. Yap Kow	RM 3,000.00
▪ PP Choo Jee Sam	RM 20,000.00

Donation made by PP Shirley Thum were the “angpow” collection during her son’s wedding dinner and the amount was capitalized and only interest drawn annually would be awarded to students. PP Choo Jee Sam’s donation was disbursed immediately.

- In RY 2002-2003, President Patrick Ng realising the then bad economic situation, pledged similar amount as RY 2001-2002 and warranted the Club to give whatever the club can raise. The distribution and quantum remained the same as the previous Rotary Year and only those truly eligible students and undergraduates received scholarship and grants. The following donation was amongst others received during RY 2001-2002: -

**CRITERIA FOR SECONDARY SCHOOLS EDUCATION GRANT**

The Pudu Rotary Club's Secondary School Education Grant is awarded, amongst others, under the following criteria:-

1. Poor, deserving students in secondary schools within the territorial limits of Pudu Rotary Club (especially those from large families)
2. The applicants must have good scholastic record and of good character.
3. The applicants must not receive other form of financial assistance.
4. The money received by the students must be used for their expenses in school or for examination fees, books, uniforms, shoes, transportation or similar items over the next 12 months from the date of awards.
5. The Secondary School Education Grant are made out in cheques in the name of the schools and are to be disbursed by the schools to the successful applicants. Schools are required to give a statement of account to the Club as to how the money has been expended.
6. Successful applicants are required to correspond with the donor by way of letters at least once every 3 months, with copies of such letters sent to the Chairman, Pudu Rotary Club Scholarship Committee. For successful applicants sponsored by the PRC Charity Foundation, they are required to correspond with Counselors, (Rotarians nominated by PRC).
7. Non compliance with the above conditions may result in the withdrawal of the Secondary School Education Grant The Scholarship Awards Committee is also guided by the recommendation of the respective school Principal and the documents submitted by the applicant in support of his or her application. Deserving recipients may apply and be considered for scholarship awards in the following Rotary Year.
